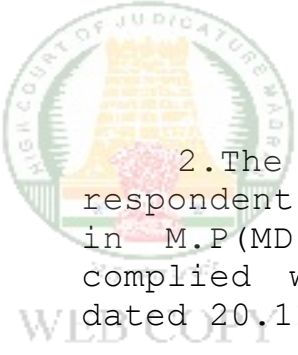
Prayer in WP(MD). 15699/ 2014 :
