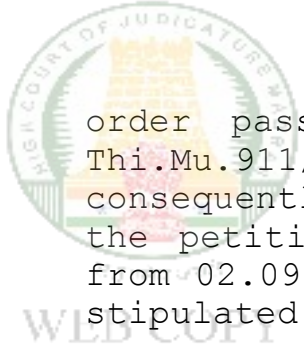

Prayer in WP(MD). 12469/ 2012 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus, calling for the records relating to the return of request for the approval of the petitioner's appointment in the post of Watchman in 4th Respondent School in his proceedings in O.Mu.No. 2813/A4/2006, dated 15.05.2006 on the file of the 3rd respondent and quash the same.

Prayer in WP(MD). 1228/ 2013 :

Prayer in WP(MD). 17578/ 2014 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus, calling for the records relating to the order passed by the 3rd responden tin his Proceedings in Na.Ka. No. 5659/A3/14 dated 25.09.2014 and quash the same and consequently direct the respondents to approve the petitioner s appointment as Junior Assistant in 4th respondent school from the date of the Petitioner s appointment and to pay all the service an dmonetary benefits within stipulated time.

Prayer in WP(MD). 21716/ 2015 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Certiorarified Mandamus calling for the records relating to the order passed by the 3rd respondent in his proceedings in O.Mu.No.5570/A3/2012, dated 8.3.2014 and quash the same and consequently direct the respondents to approve the petitioners appointment as Record Clerk in 4th respondent school from the date of the petitioners appointment on 24.9.2012 and to pay all the service and monetary benefits within stipulated time.
