directed to grant permanent status to the petitioner with all benefits, after twelve weeks from today, if no writ petition is filed and no interim order is obtained."

3. Now, it is represented by both sides that the contemnor/second respondent has challenged the order of the Inspector of Labour, Madurai/first respondent in writ petition in W.P(MD)No.22667 of 2016.
