ORDER

This contempt petition is filed to punish the contemnor/2nd respondent for willfully disobeying and non-complying with the order of this Court dated 27.11.2015 in W.P(MD)No.21155 of 2015.

2. This Court, by an order dated 27.11.2015, made in W.P(MD) No.21155 of 2015, passed the following order:-

"4.In these circumstances, the second respondent is directed to grant permanent status to the petitioner with all benefits, after twelve weeks from today, if no writ petition is filed and no interim order is obtained."

3.Now, it is represented by both sides that the contemnor/second respondent has challenged the order of the Inspector of Labour, Madurai, who is the first respondent in the writ petition in W.P(MD)No.21155 of 2015 in another writ petition.



4. Recording the above-said submission, this Contempt Petition is closed. No costs.
