Prayer in CRL OP(MD). 2488/ 2016 :

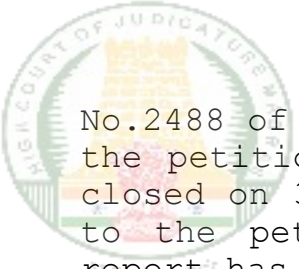
