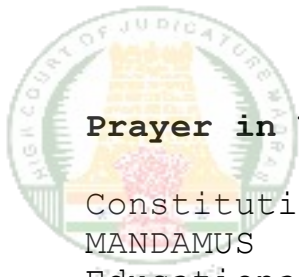

Writ Appeal preferred under clause XV of Letters patent against the interim order passed by this Court, dated 22.12.2015 in M.P.(MD)No.1 of 2015 in W.P.(MD)No.23365 of 2015.

Prayer in MP(MD) . 1/ 2015 in WP(MD) .23365/2015 :

Petition filed to grant an Ad Interim Order directing the 3rd respondent District Elementary Educational Officer to provisionally approve forthwith the appointment of the petitioner as Secondary Grade Teacher in the 5th respondent school namely TNDTA Primary School, Jambulingapuram, Tuticorin District w.e.f. the date of the petitioners appointment viz., 01.08.2012 with all attendant benefits, within a reasonable time.



Prayer in WP(MD) . 23365/ 2015 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue WRIT OF MANDAMUS directing the 3rd respondent District Elementary Educational Officer to approve forthwith the appointment of the Petitioner as Secondary Grade teacher in the 5th respondent school namely, TNDTA Primary School, Jambulingapuram, Tuticorin District w.e.f. the date of petitioners appointment viz., 01.08.2012 with all attendant benefits including the arrears of salary and allowance.
