2.It is represented by the learned Additional Public Prosecutor that inadvertently without realising the fact that on 31.10.2015, the case was closed as mistake of fact, submissions have been made on 06.11.2015 and this Court directed the respondent to file final report and now, Referred Charge Sheet No.65/2016 has been served on the petitioner.

3.Even though Mr.Parthiban, Inspector of Police, has taken charge subsequently, the officer who has issued the referred charge sheet notice namely, Mr.Ulaganathan, is present before this Court and his presence is dispensed with.

4.In view of the above submission that even before the order dated 06.11.2015, the case was closed as mistake of fact on 31.10.2015, this Contempt Petition is closed. It is open to the



petitioner to file protest petition and agitate her rights in accordance with law.
