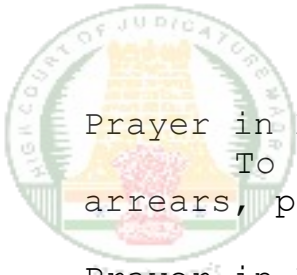

Prayer in MP(MD).1/2014 in WP(MD).11509/2014:

To direct the respondent 4 and 5 to release the salary and arrears, pending disposal of the above WP and thus render justice.

Prayer in WP(MD). 11509/ 2014 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, to direct the 5th Respondent to approve the appointment of the petitioner made by him in the light of G.O. Ms. No. 181 Education Department dated 15.11.2011 from the date of his appointment and consequently direct the respondents to pay all the consequential service and monetary benefits to the petitioner on the basis of the representation dated 12.06.2014 in accordance with law.
