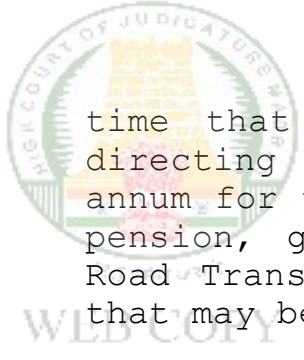

time that may be stipulated by this Honble Court and further directing the Respondents to pay interest at the rate of 18% per annum for the belated payment of provident fund, Commuted Value of pension, gratuity, refund of his contribution from Institute of Road Transport, and Social Scheme arrears within the time limit that may be fixed by this Honble Court.
