To pass an Ad-Interim Direction directing the fourth respondent to reinstate the petitioner in service as street light helper further permit him to continue in service till attaining the age of 60

Prayer in WP(MD). 11008/ 2016 :

Writ Petition is filed under Article 226 of the Constitution of India, praying that in the Circumstances stated therein and in the affidavit filed therewith the High Court will pleased to issue a Writ or order in diretion in the nature of Writ of Certiorarified Mandamus to call for records relating to impugned order passed by the 4th respondent in Pro.Na.Ka.No. 75/2016/A1 dated 30.04.2016 and quash the same as illegal and consequently direct the respondents to allow the petitioner to continue in service as Street Light Helper, Neyyur Town Panchayat till he reaches the age of 60 prescribed for the basic Service.
