No.121 Finance (Allowances) Department dated 22.04.2015 together with interest at the rate of 18% per annum from the date of his retirement to till the date of settlement within the time that may be stipulated by this Hon'ble Court and further directing the Respondent to pay interest at the rate of 18% per annum for the belated payment of the Provident Fund and Employees Social Protection Scheme Arrears within the time that may be stipulated by this Hon'ble Court.
