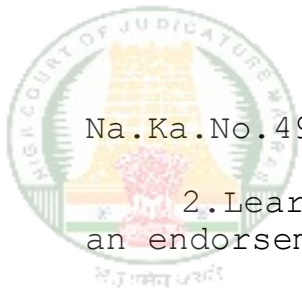
Prayer in WP(MD)No.12869/2016 :
