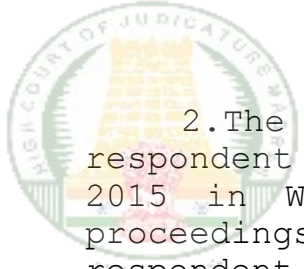
Prayer in WP(MD). 18890/ 2015 :
