Pleased to pass an order of direction, directing the respondents 1 and 2 to grant interim approval of the Petitioners appointment as Secondary Grade Teacher in the 4th Respondent Minority Aided School without insisting for passing of TET.

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Certiorarified Mandamus in the nature of writ calling for the records relating to the proceedings of the impugned notice dated 18.03.2014 in so far as the petitioner is concerned on the file of the 3rd respondent and quash the same and further directing the 3rd respondent to resubmit the petitioner's proposal for approval to the 1st respondent and consequently directing the 1st respondent to grant approval to the appointment of petitioner as Secondary Grade Teacher in the 4th respondent school with effect from 15.6.12.
