Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue Writ of CERTIORARIFIED MANDAMUS calling for the records relating to the impugned order passed by the 3rd respondent in his proceedings in Na.ka.No.2228/22/2013 dated 29.07.2013 and quash the same as illegal and consequentially to direct the respondents to consider the petitioners for promotion to the post of B.T.Assistant (Maths) in the Panchayat Union Middle School, Thottanampatti, Vedachandur union, Dindigul District as per the panel of Secondary Grade Teachers fit for promotion to the post of B.T.Assistant (Maths) as on 01.01.2013 within the period that may be stipulated by this Hon'ble Court.
