Prayer in WP(MD). 17204/ 2015 :

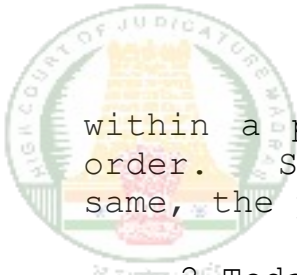
