Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Certiorarified Mandamus, calling for the records relating to the impugned order of the 1st respondent in proceedings R.NO. 46566/VA2/2006, dated 26/10/2010 and quash the same and consequently direct the first respondent herein to regularize the period of suspension with all monetary and attendant benefits.

Considering the above, liberty is given to the petitioner to make a representation to the respondents concerned and as and when such representation is made, the concerned respondent shall pass appropriate orders on the same, within a period of six weeks from the date of receipt of a copy of this order.
