Prayer in MP(MD). 2/ 2015 in WP(MD).23324/2015 :

Praying to grant an AD INTERIM ORDERS directing the 2nd respondent Joint Director to provisionally approve forthwith the appointment of the petitioner as Assistant Professor (English) in the 4th respondent College, namely Sarah Tucker College (Autonomous), Tirunelveli and disburse the grant-in-aid towards her salary and allowances w.e.f. the date of appointment viz. 17.03.2014 within a reasonable time as may be specified by this Hon'ble Court, pending disposal of the Writ Petition.

Prayer in WP(MD). 23324/ 2015 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus calling for the records relating to the impugned proceeding issued by the 2nd respondent Joint Director in A. Thi. Mu. No. 10076/Aa3/2015 dated 14.09.2015, Quash the same, the petitioner is concerned, and further direct the 2nd respondent Joint Director to approve forthwith the appointment of the petitioner as Assistant Professor (English) in the 4th



respondent College, namely Sarah Tucker College (Autonomous), Tirunelveli and disburse the grant-in-aid towards her salary and allowances w.e.f. the date of her appointment viz., 17/03/2014.
