Prayer in MP(MD). 1/ 2013 in WP(MD).12502/2013 :

To grant an Ad interim orders directing the 3rd respondent District Elementary Educational Officer to approve the appointment of J.Jeyanthi as BT Assistant (Science) in the petitioner school w.e.f the date of her appointment on 26.6.2012 with all attendant benefits within a reasonable time as may be specified by this Honble Court with a condition that he should pass the teachers Eligibility Test within 5 years from the date of appointment, pending disposal of the WP.

Prayer in WP(MD). 12502/ 2013 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ, Order or Direction in the nature of WRIT OF MANDAMUS directing the 3rd respondent District Elementary Educational Officer to approve forthwith the appointment of J.Jeyanthi, as BT Assistant (Science) in the petitioner school w.e.f the date of her appointment on 26.6.2012 with all attendant benefits including the arrears of salary and allowances.
