Prayer in WP(MD). 22378/ 2015 :

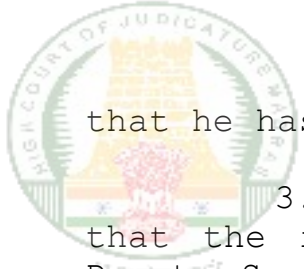
