Deva Sutha Anita as Secondary Grade Teacher in the petitioner-school w.e.f., the date of appointment on 20.12.2011 and disburse grant-in-aid towards salary w.e.f., 01.11.2012 and other attendant benefits, pending disposal of the WP

Prayer in WP(MD). 1844/ 2016 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus calling for the records relating to the impugned proceeding 3rd respondent herein in Tho.Moo.Mu.1568/A2/2012 dated 22.11.2012, Quash the same and futher direct the respondents herein to approve the appointment of Tmt.C.Deva Sutha Anita as Secondary Grade Teacher in the petitioner-school w.e.f. 20.12.2011 and disburse grant-in-aid towards salary w.e.f., 01.11.2012 and other attendant benefits.
