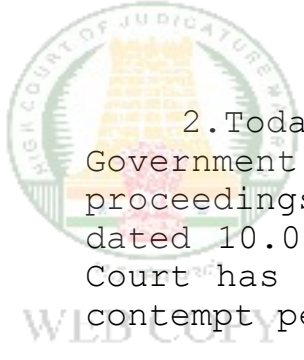
Prayer in WP(MD). 1196/ 2016 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus calling for the records relating to the impugned proceedings issued by the 3rd respondent herein in O.Mu.No.5409/Aa2/2015 dated 04.01.2016 quash the same, and further direct the 3rd respondent herein to approve the petitioners appointment as BT Assistant (Science) in the 4th respondent school w.e.f. 24.06.2013 with salary and other attendant benefits.
