Prayer in WP(MD). 18856/ 2015 :

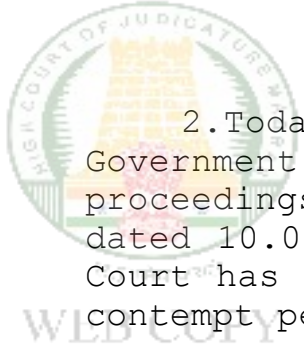
