Prayer in MP(MD). 1/ 2013 in WP(MD).13173/2013 :

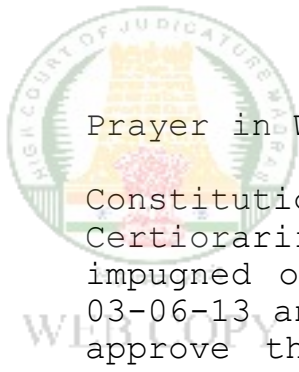

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus, to call for the records relating to the impugned order of the 3rd respondent in O.Mu.No.5569/A1/2012 dated 03.06.2013 and quash the same and further direct the 3rd respondent approve the appointment of Mr.S. Balamurugan, B.T. Assistant (History) w.e.f. 15.11.12 in the petitioner' s school and pay all monetary and service benefits with arrears.

Prayer in MP(MD). 1/ 2013 in WP(MD).13174/2013 :

To pass an order of interim direction to the 3rd respondent to release the grant in - aid to the petitioner school towards the salary of the Mr.J.Alagan, appointed as B.T. Assistant (History) w.e.f 15.11.12 with arrears of salary pending disposal of the writ petition and thus render justice.



Prayer in WP(MD). 13174/ 2013 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus to cal for the records relating to the impugned order of the 3rd Respondent in O.Mu.No.5570/A1/2012 dated 03-06-13 and quash the same and further direct the 3rd Respondent to approve the appointment of mr.J.Alagan, B.T. Assistant (History) W.e.f 15.11.12 in the petitioner's school and pay all monetary and service benefits with arrears .
