Prayer in WP(MD). 168/ 2010 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a WRIT OF MANDAMUS, directing the respondents to extend to the petitioner the benefit of the order dated 21-02-2008 of the Division Bench of the Madras High Court in W.P.Nos.29644 and 29645 of 2003 which was implemented by the Government in G.O.Ms.No.234 School Education (G2) Department dated 10-09-2009 within a stipulated period and to pass such further or other orders as this Hon'ble Court may deem fit and proper in the circumstances of this case and thus render justice.
