To grant an order of Ad-Interim orders directing the 3rd respondent herein to grant temporary approval to the appointment of petitioner as Secondary Grade Teacher in the 5th respondent school from 24.08.2012 onwards with salary and other attendant benefits, pending disposal of the WP.

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Certiorarified Mandamus calling for the records relating to the impugned proceedings issued by the 4th respondent herein in O.Mu.No.890/A2/2014 dt.29.04.2014 and the subsequent proceedings issued by the 3rd respondent herein in Na.Ka.No.3170/A5/2014 dated 06.08.2014, quash the same, and further direct the 3rd respondent herein to approve petitioners appointment as Secondary Grade Teacher in the 5th respondent school from 24.08.2012 onwards with salary and other ..

**ORDER**
