Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Certiorarified Mandamus calling for the records relating to the impugned proceedings issued by the 4th respondent District Educational Officer in O.Mu.No.1781/A2(e1)/2015 dated 26.08.2015, quash the same and further direct the 4th respondent District Educational Officer to approve forthwith the appointment of M. Sheeba Rose as BT Assistant in Science in the petitioners school w.e.f. the date of her appointment on 15.12.2014 with all attendant benefits including the arrears of salary and allowance.
