Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, direct the respondents to settle retirement benefits of the Petitioner including Gratuity, Leave Salary , Post Retirement Benefit Fund Amount, monthly pension with enhanced dearness allowance at the rate of 80% in terms of letter (Ms) No. 155 Transport(E) Department dated 25.07.2013 together with interest at the rate of 18% per annum from the date of his retirement to till the date of his settlement and further directing the respondents to settle the interest at the rate of 18% per annum for the belated payment of the Provident Fund, the Commuted Value of Pension and Employees Social Protection Scheme arrears amount within the time that may be stipulated by this Hon'ble Court.
