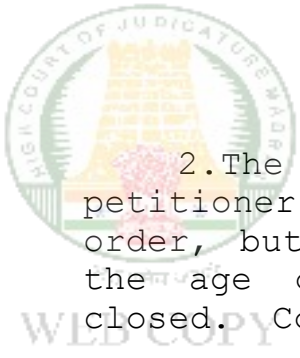
Prayer in WP(MD). 1270/ 2016 :
