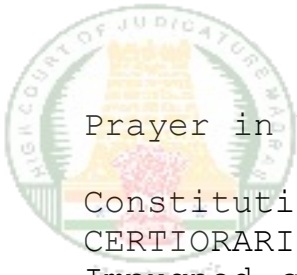

Pleased to grant an AD-INTERIM DIRECTION directing the 3rd respondent to allow selection grade and special grade scales of pay of Rs.9300-34800+4200 (GP) and 9300-34800+4400(GP) to the post of Book Binder Grade-II as per revised Selection Grade and Special Grade scale of pay as clarified in Government Letter No.63305/Pay-cell/2010-1 dated 08/11/2010 on the recommendation of

Commission - 2010 and pay all monetary benefits.



Prayer in WP(MD). 21132/ 2015 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a WRIT OF CERTIORARIFIED MANDAMUS calling for records relating to the Impugned circular issued by the 3rd respondent in his proceedings Iyyak.No.52960/A1/2013 dated 15.04.2014 and quash the same as illegal and consequently to direct the 3rd respondent to allow selection grade and special grade scales of pay of Rs.9300-34800+4200(GP) and 9300-34800+4400(GP) to the post of Book Binder Grade-II as per revised Selection Grade and Special Grade scale of pay as clarified in Government Letter No.63305/pay - cell/2010-1 dated 08.11.2010 on the recommendations of the one man commission 2010 and pay all the monetary benefits accruing thereon within the period that may be stipulated by this Court.
