Prayer in WP(MD). 2785/ 2016 :

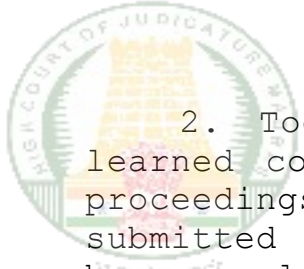
