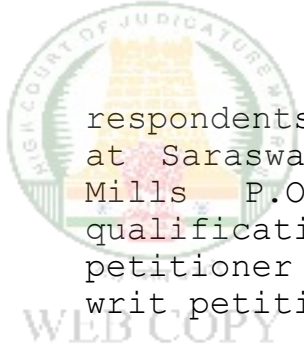

3. Recording the statement of learned Additional Government Pleader, this contempt petition is closed.

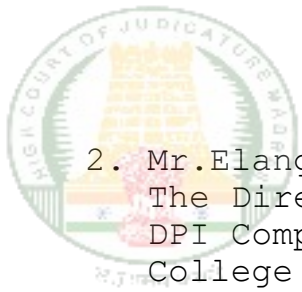
