Prayer in WP(MD)No.1935/2015:-

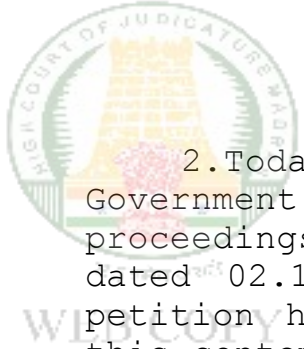
Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus, calling for the records relating to the Impugned Proceedings issued by the 3rd respondent Joint Director (Secondary Education) vide Moo. Mu. No. 79047/D2/E3/2013 dated 11.12.2014 quash the same and further direct the respondents 1 to 5 herein to approve the appointment of petitioner as Office Assistant in the 6th Respondent school w.e.f., the date of appointment viz., 09.06.2010 with salary and all attendant benefits.
