Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Certiorarified Mandamus to call for the records pertaining to the impugned order in O.Mu.No.10218/A4/2014 dt.25.06.2014 on the file of the Respondent No.4 and quash the same as illegal and consequently to direct the 4th Respondent to approve the appoint of the petitioner as B.T.Assistant (mathematics) in the 5th Respondent school with effect from the date of appointment on 20.06.2011 with benefits within a stipulated time that may be prescribed by this Honble Court.
