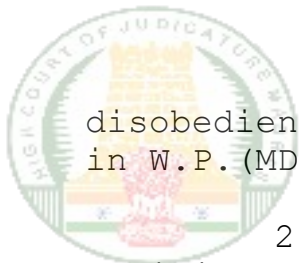
Prayer in WP(MD). 22367/ 2015 :
