This Criminal Original Petition has been filed to quash C.C.No.191 of 2000 pending on the file of the Judicial Magistrate, Karaikudi.

2.Though the learned counsel for the petitioner raised several grounds for quashing the charge sheet filed by the respondent Law Enforcing Agency, he submitted that it would suffice, if a direction is issued to the trial Court to complete the trial within a time limit that may be stipulated by this Court and also to permit the petitioner to raise all the grounds raised in this petition before the trial Court.
