(ii)That there be no order as to costs in this Second Appeal.

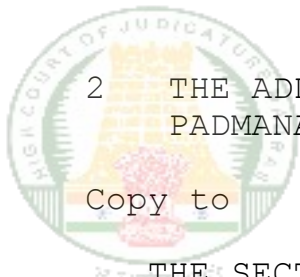
