PRAYER: Writ Petition is filed under Article 226 of the Constitution of India to issue a Writ of Mandamus directing the third respondent to implement the order passed by the first and second respondents in their proceedings Na.Ka.No.O.Mu.E4-11398-13 dated 23.05.2013 and Na.Ka.No.O.Mu.A3-5149-2012 dated 04.09.2012 and to remove the encroachment made by the fourth and fifth respondents at Mahibalanpatti Sundakadu Group S.No.112-1 at Salaipatti, Mahibalanpatti Post Thiruppathur Taluk, Sivagangai District, within the period that may be stipulated by this Court.

The petitioner submitted a representation to the Tahsildar, Thiruppathur to remove the encroachment stated to have been put up by the fourth and fifth respondents in Mahibalanpatti Sundakadu Group S.No.112-1 at Salaipatti, Mahibalanpatti Post Thiruppathur



Taluk, Sivagangai District. Since follow-up action was not taken, the petitioner has come up with this Writ Petition.

2. We direct the Tahsildar, Thiruppathur, Sivagangai District, the third respondent herein, to consider and dispose of the representation submitted by the petitioner dated 21 August, 2012, on merits and as per law, after issuing notice to the fourth and fifth respondents. Such exercise shall be completed, within a period of four months from the date of receipt of a copy of this order. We also direct the petitioner to forward a copy of the representation dated 21 August, 2012 along with a copy of this order, so as to enable the third respondent to dispose of the matter, within the time stipulated above.

3. The Writ Petition is disposed of with the above direction. No costs.
