4.The learned counsel for the petitioner would submit that the petitioner, being the Vice President of Venkatachalapuram Village, sent a representation to the first and second respondents, alleging some malpractices committed by the third and fourth respondents, in the Panchayat Office and requested appropriate action against them. Since, no action was taken, the petitioner is before this Court.

5.The learned Special Government Pleader appearing for the first respondent, submitted that the post of President is no more in existence.

6.Recording such submission, the writ petition is closed. However, it is always open to the first and second respondent, to take appropriate action in accordance with law, if any misappropriation or malpractice, as alleged by the petitioner, is noticed. No costs. Consequently, MP(MD)No.1 of 2013, is closed.
