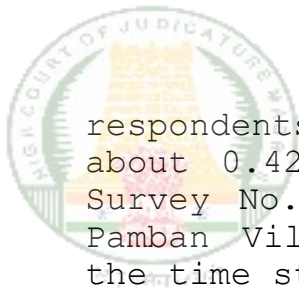

3.This writ petition is disposed of accordingly. No costs.

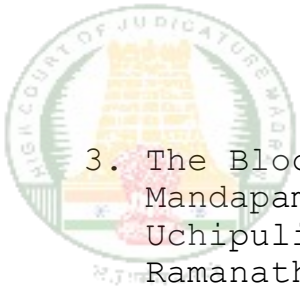
