PRAYER: Writ Petition is filed under Article 226 of the Constitution of India praying for the issuance of a Writ of Mandamus, by directing the second respondent to issue permission to the petitioner for digging of bore well within Kodaikanal Municipal Limit, in Dindigul District, by considering the petitioner's representation, dated 14.03.2013 within a time frame as fixed by this Court.

ORDER

6. The writ petition is disposed of as above. No costs.
