CRIMINAL PETITION No.7381 OF 2017

ORDER:

Heard learned counsel for the petitioners, who are no other than respondents in D.V.C.No.2 of 2017 on the file of the XIX Metropolitan Magistrate, Cyberabad at Kukatpally, Ranga Reddy District, outcome of the complaint by the 2nd respondent.

In fact, as laid down by this Court in *Gaddameedi Nagamani V. The State of Telangana rep. by Public Prosecutor* (CrI.P (SR) Nos.22371 of 2015 and batch), there is an efficacious appeal remedy under Section 29 of the Domestic Violence Act, to impugn the cognizance. Hence, there is nothing to entertain the quash petition but for giving liberty to file appeal if at all within one week from date of receipt of copy of this order before the Court of Sessions and in such an event the learned Sessions Judge shall entertain the appeal without regard to period of limitation for appeal. The petitioners are further at liberty to file an application for one to represent others under Rule 37 of the Criminal Rules of Practice for the learned Magistrate after hearing to consider and permit with necessary conditions.

Accordingly, the Criminal Petition is disposed of.

Miscellaneous petitions pending if any, shall stand closed.
