Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the Affidavit filed herein the High Court will be pleased to issue an order writ or direction more particularly one in the nature of writ of mandamus declaring the order passed by the 1st respondent in Appeal No.6/2007 dated 29.9.2007 setting aside the order of the 2nd respondent in D.Dis.No.A3/3033/2007 dated 20.2.2007 declaring the petitioner as landless poor person by invoking the suo moto appellate powers not vested in him as illegal, arbitrary, without jurisdiction and unjust and consequently set aside the order passed by the 1st respondent and direct the respondents to continue the petitioner as the cultivating tenant of the 3rd respondent.
