2. On 05/01/2017 this Court admitted the above Civil Miscellaneous Appeal.

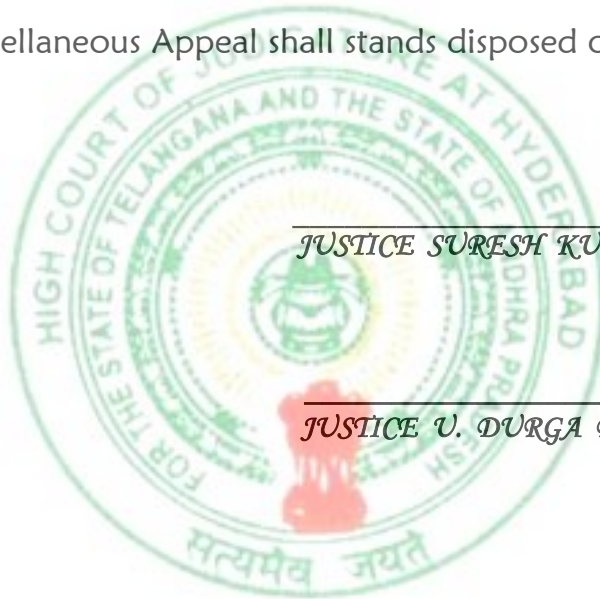
