CRIMINAL PETITION No.1676 of 2017

ORDER :

Heard learned counsel for the petitioners, learned Public Prosecutor and perused the record.

2. Though there is service of notice on unofficial respondent Nos.2 to 12, there is no representation on their behalf.

3. This petition is filed to quash the order, dated 20.10.2016, passed in CrI.M.P.No.101 of 2014 in CrI.M.P.No.163 of 2013 in M.P.No.126 of 2000 on the file of the Assistant Sessions Judge-cum-Chief Judicial Magistrate, Nellore. The said order reads as under:

“Orders pronounced. Heard. Perused record. Petition is allowed.”

4. There are no reasons assigned in the order. The jurisdiction of the Court in passing the said order is also in question. The Court below is required to pass a reasoned and detailed order. As the order is bereft of reasons and the maintainability of the criminal petition before the Court is in question, it is appropriate to set aside the said order and remand the matter to the Court concerned to deal with the matter after giving opportunity to both parties.

5. Accordingly, the criminal petition is allowed and the matter is remanded back to the Court concerned for fresh consideration after giving opportunity to both parties.

Miscellaneous petitions pending, if any, shall stand closed.
