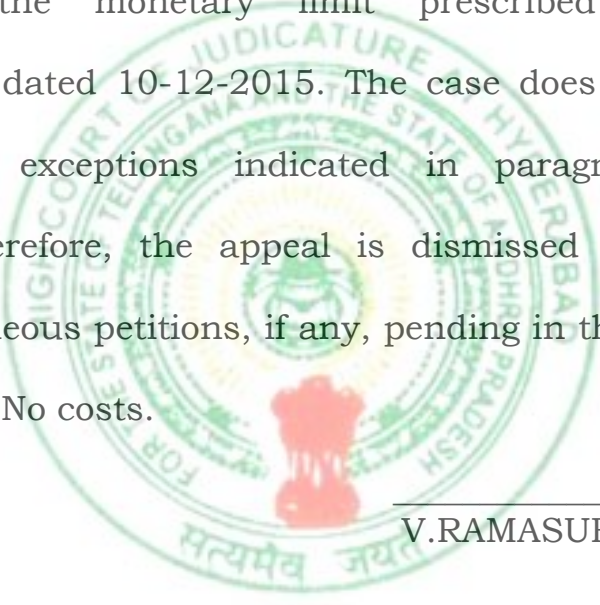

The appeal is by the Revenue under Section 260A of the Income Tax Act, 1961.
