disposed of.



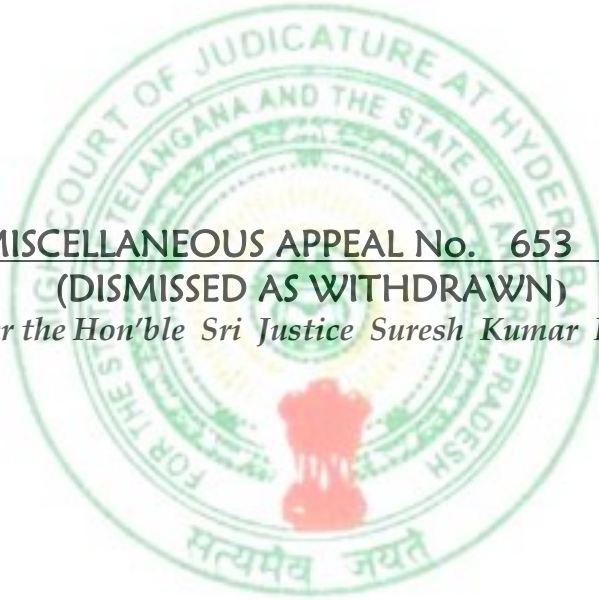
