The Court made the following Order:

**“This petition is filed under Section 439 Cr.P.C. to grant bail to the petitioner-A3
for the offences alleged under Sections 3 and 4 of Gaming Act, 1974 and 20 (b) (ii) (c)
r/w 8 (c) of NDPS Act, 1985.**

**2. Heard learned counsel for the petitioner-A3, learned Additional Public
Prosecutor representing the State and perused the record.**

**3. No ganja was seized from the possession of the petitioner-A3. A10, A12
and 13 were granted bail by this Court as per common order, dated 21.11.2017 in
Crl.P.Nos.10433 and 10543 of 2017.**

**4. Having regard to the nature of allegations and the investigation conducted
so far, the petitioner-A3 can be granted bail under Section 439 Cr.P.C. on some
conditions.**

**5. In the result, the Criminal Petition is allowed and the petitioner-A3 is
ordered to be released on bail on his executing a personal bond for Rs.25,000/- (Rupees
twenty five thousand only) with two sureties each in a like sum to the satisfaction of I**

Additional District and Sessions Judge, Nellore, SPSR Nellore District. On release, the petitioner-A3 shall not leave India without permission of the trial Court.”
