The petition coming on for hearing, upon perusing the petition and the affidavit filed herein and the orders of the High Court dated. 08-11-2017 & 15-12-2017 made in Crl.P.No. 10414 of 2017 & Crl.P.M.P.No. 13896 of 2017 and the order dated. 09-02-2018 made in I.A.No. 1 of 2018 and upon hearing the arguments of Sri D.Kodanda Rami Reddy, Advocate for the Petitioners and of the Public Prosecutor (AP) for the Respondent, the Court made the following

ORDER:
