Petition under Section 437 of Cr.P.C. praying that in the circumstances stated in the grounds filed herein, the High Court may be pleased to grant regular bail to the Petitioner and enlarge the petitioner on bail in Crime No. 34 of 2016 of Mareduilli Police Station, East Godavari District, Andhra Pradesh.

The Petition coming on for hearing, upon perusing the petition and the grounds filed herein and upon hearing the arguments of Sri Milind G Gokhale, Advocate for the Petitioner and of the Addl. Public Prosecutor (AP) for the Respondent, the Court made the following

ORDER:

“ Heard learned counsel for the **petitioner/A.3** and learned Additional Public Prosecutor for the respondent State, and **perused** the record.

This petition is filed under **Section 439 Cr.P.C.** for grant of bail to the **petitioner/A.3** in Crime No. 34 of 2016 of **Mareduilli Police Station, East Godavari District**, for the offence punishable under **Section 8(c)** read with **Section 20(b)(ii)(c)** of NDPS Act.

It is brought to the notice of this Court that **A.1** and **A.2** were granted bail as per the orders passed by this Court in **CrI.P.No.13094** of 2016 on **12.09.2016**. It is alleged that pursuant to the confession made by **A.1** and **A.2**, the **petitioner/A.3** is made as accused in this case. The **petitioner/A.3** was remanded to judicial custody on **10.08.2017**. Under these circumstances, the **petitioner/A.3** can be enlarged on bail on some conditions.

In the result, the **petitioner/A.3** is ordered to be released on bail on his executing a personal bond of **Rs.10,000/- (Rupees Ten Thousand only)** with two sureties for a like sum each to the satisfaction of the learned I-Additional District and Sessions Judge, Rajamahendravaram. On such release, the **petitioner/A.3** shall attend before the Station House Officer, Mareduilli Police Station, on every Sunday between 9.00 and 10.00 a.m. till filing charge sheet.

Accordingly, the Criminal Petition is allowed.”
